STUDIOS, DESIGN & PEOPLE

design & branding

The Design and Branding department (D&B) was launched in April 2012 and we have since completed two websites: Perfect Steps and La Maisons Sans Souci. We have also secured three other websites which are currently being worked on. Further meetings are set up for 2013 for other websites.

The WEBNOVOFF offer was successful in securing website clients during the latter part of 2012.

So far our client base for D&B is through both word of mouth from previous clients and via Facebook. To date no clients have been gained through our website.

One In Ten also maintains the GMB union branch website free of charge and this has helped to both spread our brand and has given us technical experience in the use of WordPress and web servers.

Our Facebook page has 37 likes and twitter has 14 followers.

brand relaunch

On 1st October 2012 the One In Ten Productions UK branding was relaunched with a new logo design, font and colour pallet and a new look website. A brand guideline was created which is accessible to all One In Ten staff who require it on the Google Drive.

The website relaunch was timed in with the new servers purchased through RNJ.com and our technical assistant Richard Jones. Some stability issues delayed the original website live date by 1 month but this has since been resolved.

A few issues still remain with WordPress and access however this should be resolved in the next few months.

studios & equipment

On 1st January 2012 One In Ten were given access to an iMac computer for use with video and audio work at the Longford River Studios in Surrey. This is being leased along with the studios / offices from Chris Fenner.

We also have access to an iPad 3 and iPhone 4 leased from Jennifer Chislett.

During 2013 One In Ten hope to gain an additional room at LFR Studio although this is still under negotiation.

people, pay & administration

The People, Pay & Administration (PPA) department hopes to launch its Your Music service in mid 2013. This will be used to bring all paperbased forms online and will include links to webmail services (provided by Gmail), the Google Drive, Pay & Royalty Statements and various other information for One In Ten employees.

The Google Drive was launched for One In Ten in September 2012 and has enabled us to work more efficiently. All future documents should be electronic to reduce cost and to make online working easier.

The Seven Wives soundtrack was digitally distributed onto iTunes, Amazon and Spotify in early 2012 through our digital distributor TuneCore and courtesy of Chris Fenner.

As of 1st January 2013 the TuneCore balance is at \$10.48 which unfortunately means this project is at a loss.

The IndieGoGo campaign which was launched in 2011 and complete early 2012 raised \$18 which will go towards the feature length motion picture of this musical.

The YouTube promotional film (starring Greg Kelly & Rachel Mary Johnson) launched in 2010 has amassed 902 views since its upload.

The Seven Wives Facebook page has remained at 200 likes and the twitter account has 47 followers.

Some of the music has received reworking.

This project has unfortunately been delayed further due to outside commitments. This now leaves us with another year to complete the film and the single recording to go with it.
